Damages could be higher in an individual civil suit, but not guaranteed. You would have to pay for your own lawyer. You can also <u>complain to the Information and Privacy Commissioner</u> (IPC) (noted above), but it's unclear what additional value this would have when ODSP has already reported itself. Before making a complaint to IPC, you should get advice from the class actions lawyers or a civil litigation lawyer about the potential impacts of an IPC complaint on a civil suit.
